

ORDINANCE #15-02:

AN ORDINANCE AMENDING CHAPTER 91 OF THE PINEHURST MUNICIPAL CODE FOR THE VILLAGE OF PINEHURST, NORTH CAROLINA.

THAT, WHEREAS, the Village Council of the Village of Pinehurst adopted an ordinance dated October 20, 1980, establishing and implementing certain authorized police powers for the purpose of prescribing regulations governing conditions detrimental to the health, safety and welfare of its citizens; and

WHEREAS, the Municipal Code has been subsequently amended from time to time as conditions warrant;

NOW, THEREFORE, BE IT ORDAINED AND ESTABLISHED by the Village Council of the Village of Pinehurst, North Carolina, in a regular meeting assembled this 13th day of February, 2015 as follows:

SECTION 1. That Chapter 91 of the Pinehurst Municipal Code is hereby amended by adding a new Section 91.04 to read as follows:

91-04 LIMITING NUMBER OF DOGS.

Each owner or custodian of dogs in the Village of Pinehurst shall keep, harbor or maintain no more than three (3) dogs on each ½ acre of property owned by said owner or custodian.

SECTION 2. That this Ordinance shall be in full force and effect from and after the date of its adoption.

ORDINANCE #15-01:

AN ORDINANCE AMENDING THE ORDINANCE APPROPRIATING FUNDS FOR OPERATIONS OF THE VILLAGE OF PINEHURST, REGARDING REVENUES AND EXPENDITURES OF THE GENERAL FUND FOR THE VILLAGE OF PINEHURST, NORTH CAROLINA (FAIR BARN PARKING LOT IMPROVEMENTS).

THAT WHEREAS, the Village initially appropriated \$40,000 in the original budget for fiscal year 2013-2014 for landscaping and parking improvements at the Historic Fair Barn at the Harness Track;

WHEREAS, the Village did not anticipate the total cost of this project exceeding the amount initially budgeted for June 30, 2015;

WHEREAS, additional funds are needed in the amount of \$11,000 to expand the scope of the project, and the Parks and Recreation Director deems these funds necessary to keep the parking lot away from the manure pile;

NOW, THEREFORE, BE IT RESOLVED by the Village Council of the Village of Pinehurst, North Carolina, in work session assembled this 13th day of February, 2015 as follows:

SECTION 1. To amend the General Fund with regard to revenues and expenditures, the revenue and expenditure accounts are to be changed as follows:
